5. Larissa Bright Australia® agrees that:

6. The Distributor agrees that:

6.1: The Distributor may not solicit orders for or sell any of the products via an independent website. The company provides a website for Distributors clients to purchase product if applicable whereby the client can enter the Distributors name in order for the Distributor to benefit from the sale. You may also purchase from LBA your own website.

6.2 The Distributor sells the products on their own account and not as an employee of Larissa Bright Australia®.

6.3 Larissa Bright Australia® may impose prohibitions or restrictions on the use of its business name, company logo and on advertising by the Distributor in order to protect Larissa Bright Australia's rights, reputation and image.

6.4 If, for any reason, in respect to any products originally sold by Larissa Bright Australia® to the Distributor, Larissa Bright Australia® for any reason, gives to a consumer a refund of the whole or any part of the price paid by the consumer, Larissa Bright Australia® may require the Distributor to reimburse the amount it has refunded the consumer.
